Tank Mixtures for Woody and Herbaceous Weed Control in Forestry Conifer Release

Directions for Use

In Maine Accord concentrate can be applied at rates up to 2.25 quarts per acre for control and suppression of difficult-to-control hardwood species for conifer release.

Tank mixture with Arsenal Applicators Concentrate Herbicide: For release of red pine, balsam fir, red spruce, white spruce, Norway spruce and black spruce with dense tough-to-control brush and where maples make up a large component of the undesirable trees, up to 2.25 quarts per acre of Accord Concentrate may be tank mixed with 1 to 2.5 fluid ounces per acre of Arsenal Applicators Concentrate herbicide and applied as a broadcast spray.

Tank mixtures with Oust or Oust XP: For release of red pine, balsam fir, red spruce, white spruce, Norway spruce and black spruce with heavy grass and herbaceous weeds infesting the site, up to 2.25 quarts per acre of Accord Concentrate may be tank mixed with 1 to 3 oz of Oust herbicide or Oust XP herbicide to control grass and herbaceous weeds and applied as a broadcast spray.

Tank mixture with Arsenal Applicators Concentrate and Oust or Oust XP Herbicides: For release of red pine, balsam fir, red spruce, white spruce, Norway spruce and black spruce with heavy grass and herbaceous weed densities, tough-to-control brush and where maples make up a large component of the undesirable trees up to 2.25 quarts per acre of Accord Concentrate may be tank mixed with 1 to 2.5 fluid ounces per acre of Arsenal Applicators Concentrate and 1 to 3 oz of Oust or Oust XP herbicides and applied as a broadcast spray.

Follow applicable use directions, precautionary statements and limitations on the respective tank mix product labels. Use according to the most restrictive label limitations on each product label.
