#### DIRECTIONS FOR USE

- It is a violation of federal law to use this product in a manner inconsistent with its labeling.
- This FIFRA Section 24(c) label and the main EPA-registered Fusilade II Turf and Ornamental Herbicide label must be in the possession of the user at the time of pesticide application.
- Follow all applicable directions, restrictions, Worker Protection Standard requirements, and precautions on this FIFRA Section 24(c) label and the main EPA-registered Fusilade II Turf and Ornamental Herbicide label.

#### RESTRICTIONS AND LIMITATIONS

**DO NOT** apply directly to water.

Apply to:

- Non-irrigation or irrigation ditch banks, canal banks, levies, and along other waterways.
- **Seasonally dry wetlands**, including flood plains, deltas, marshes, swamps, bogs, stormwater retention ponds, storm water treatment areas, and water conservation areas. Do not apply to grasses when standing water is present in these areas.

When making applications to invasive and non-desirable grasses, use directed application approaches that minimize overspray into water.

**DO NOT** apply more than 1.5 pints (24 fl oz) per acre per treatment and 4.5 pints (72 fl oz) annually.

#### **APPLICATION INFORMATION – EMERGED INVASIVE AND NON-DESIRABLE GRASSES**

---

Fusilade II Turf and Ornamental Herbicide is a foliar-applied herbicide for the selective control of invasive and non-desirable grasses such as torpedograss (*Panicum repens*), West Indian marsh grass (*Hymenachne amplexicaulis*), para grass (*Urochloa mutica*), and Tropical American water grass (*Luziola subintegra*), in **seasonally dry wetlands**, including flood plains, deltas, marshes, swamps, bogs, stormwater retention ponds, storm water treatment areas, water conservation areas, and other areas near or adjacent to aquatic sites.

- Fusilade II Turf and Ornamental Herbicide will not control broadleaf weeds.
- Fusilade II Turf and Ornamental Herbicide will not control monocots that are classified as non-grasses, such as rushes and sedges.

**Application Methods:** Apply Fusilade II Turf and Ornamental Herbicide to the foliage of the target grasses. Apply in such a way as to maximize spray interception by the target vegetation such as directed sprays. For maximum activity, apply when grassy weeds are growing vigorously at the time of application. Application when grasses are dormant or severely water stressed may result in poor control; a methylated seed oil is recommended. Fusilade II Turf and Ornamental Herbicide may be applied by using low volume directed application techniques including, but not limited to:

- Backpack sprayer
- Manually pressurized hand wand
- Mechanically pressurized handgun
- Hydraulic boom sprayer
- Aerial

**Application Rates:** Apply Fusilade II Turf and Ornamental Herbicide as a broadcast foliar application at 24 fl oz per acre.

For backpack sprayers, manually pressurized hand wand sprayer and mechanically pressurized handgun, apply Fusilade II Turf and Ornamental Herbicide at a 3% solution volume/volume (3.8 fl oz/1 gal) for spot treatment applications to target grasses.

When making any application of Fusilade II Turf and Ornamental Herbicide, always include a surfactant in the spray solution. For best results, use a methylated seed oil adjuvant at a mixing rate of 1% volume/volume. For application by ground equipment, use a minimum of 20 to 100 gallons of water per acre to ensure uniform coverage of the target plant.

When applying Fusilade II Turf and Ornamental Herbicide with aerial application equipment, apply in a minimum of 20 gallons of water per acre.
