DIRECTIONS FOR USE

PEST CONTROL ON OUTSIDE SURFACES AND AROUND BUILDINGS

For control of Spotted Lanternfly nymphs and adults

Apply Wisdom TC Flowable using a 0.03% to 0.06% suspension as a residual spray to outside surfaces of buildings including, but not limited to, exterior siding, foundations, porches, window frames, eaves, patios, garages, refuse dumps, lawns such as grass areas adjacent or around private homes, duplexes, townhouses, condominiums, house trailers, apartment complexes, carports, garages, fence lines, storage sheds, barns, and other residential and non-commercial structures, soil, trunks of woody ornamentals and other areas where pests congregate or have been seen. Use a spray volume of 1 gallon per 1,000 square feet.

Mixing Directions: For 0.03% suspension, mix 0.5 fluid oz. of Wisdom TC Flowable per gallon of water. For 0.06% suspension, mix 1 fluid oz. Wisdom TC Flowable per gallon of water (1 fluid oz. = 2 tablespoons). Use the higher rate for heavy pest infestation, quicker knockdown or longer residual control.

ORNAMENTALS AND TREES

For ornamental applications (including, but not limited to, trees, shrubs, ground covers, bedding plants, and foliage plants) Apply the specified application rates as a full coverage foliar spray.

The higher application rate should be used when maximum residual control is desired.

RESTRICTIONS

The maximum label application rate of 1.0 fluid oz. per 1,000 square feet or 43.50 fl. oz. per 100 gallons of water is not to be exceeded.

Do not apply more than once per seven days.

Do not apply by air.

Do not apply in greenhouses, nurseries.

Do not apply this product through any kind of irrigation system.

Not for use on sod farm turf, golf course turf, or grass grown for seed.

Do not water treated area to the point of run-off.

Do not make applications during rain.

Treated wood can be burned or used for lumber one month after treatment.

Firewood is not to be treated.

Do not allow people or pets on treated surfaces until spray has dried.
