Timing of Application

CELSIUS WG Herbicide should be applied in late fall or early winter, typically before mid-December, for suppression of newly emerged *Poa annua*. CELSIUS WG Herbicide will not control mature *Poa annua* plants or plants not yet emerged. Established plants should be controlled with an alternative, appropriate postemergence herbicide. *Poa annua* suppression with CELSIUS WG may be reduced if application is made in the presence of heavy dew, fog, or mist/rain.

Use Rates

Apply CELSIUS WG Herbicide at 2.5 to 4.9 oz/A. No more than 7.4 oz/A CELSIUS WG can be applied in a 12-month period. No single application of CELSIUS WG Herbicide may exceed 4.9 oz/A.
