### 3. Hazard identification

### **Irritation:**

## 4. First-aid measures

### **General advice:**

Remove the affected individual into fresh air and keep the person calm.

### **If on skin:**

Rinse skin immediately with plenty of water for 15 - 20 minutes.

### **If in eyes:**

Hold eyes open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing.

### **If swallowed:**

If swallowed, seek medical advice immediately and show this container or label. Do not induce vomiting unless told to by a poison control center or doctor. Have person sip a glass of water if able to swallow. Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions.

### **Note to physician**

Symptoms:	shortness of breath, CNS irritability, lethargy, tremors, convulsions
Antidote:	No known specific antidote.
Treatment:	Treat symptomatically. Anticonvulsant therapy as routinely administered to humans. Diazepam may be useful in controlling convulsions. Due to the slow elimination of the active compound and its metabolites, the treatment must be continued for several days, gradually decreasing the dose of anticonvulsant based on the clinical response.

### **Hazards during fire-fighting:**

## 6. Accidental release measures

## 7. Handling and storage

### **Handling**

Safety glasses with side-shields. Tightly fitting safety goggles (chemical goggles). Wear face shield if splashing hazard exists.
