The amount and degree of drift depends on many factors including, but not limited to, the type of pesticide, application conditions, equipment and vegetation near the target spray area. Cornbelt Gardian Plus functions as a drift management tool. It will not totally eliminate spray drift.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage:

Keep this container tightly closed. Store above 40 degrees F – Do Not Freeze. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment washwater, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame.

Disposal:

Triple rinse container and pour rinsate into spray tank. Do not reuse container. Offer triple-rinsed container for recycling, or puncture & dispose of in a sanitary landfill or by other procedures approved by appropriate authorities.

GENERAL INFORMATION

Cornbelt Gardian Plus is a multi-functional water conditioning, drift & deposition management spray adjuvant built into a full-load AMS concentrate. Cornbelt Gardian Plus contains TransGard™ System technology designed for use on both transgenic and conventional crop varieties, and is formulated with a unique combination of patent-pending, high molecular weight viscosity modifiers and anti-evaporants (humectants) and water conditioners. Cornbelt Gardian Plus is designed to manage deposition and drift in three ways:

- 1. Minimizing fines due to atomization by maintaining the structure of the individual spray droplets.
- 2. Reducing spray loss due to evaporation through a propriety blend of antievaporants and emollients.
- 3. Increasing spray droplet retention on leaf surfaces by minimizing bounce and runoff.

Cornbelt Gardian Plus also conditions the spray solution by sequestering and blocking harmful metal cations which could interfere with pesticide performance. Buffering agents adjust and maintain spray pH in a neutral range. An antievaporant (humectant-emollient) ingredient allows the spray to remain moist on the leaf for maximum absorption and cuticle penetration, and a siloxane additive controls excess foaming.

DIRECTIONS FOR USE

Cornbelt Gardian Plus is intended for use with products registered for agricultural, horticultural, turf, ornamental, industrial, aquatic and non-crop uses.

CAUTION: Read and follow all pesticide directions. Do not use where the pesticide label specifically prohibits the use of an adjuvant. If the pesticide label neither recommends nor prohibits an adjuvant, the applicator must have previous experience with the adjuvant/pesticide spray mixture or should apply a small test area before making large scale applications. The addition of an adjuvant to spray mixtures may cause phytotoxicity to susceptible crop and vegetation. Care should be exercised when using on new varieties or crops not previously treated with Cornbelt Gardian Plus.

FOR WATER CONDITIONING, DRIFT & DEPOSITION MANAGEMENT

GROUND:

2.5 gallon of Cornbelt Gardian Plus per 100 gallons of spray delivers 2 quarts of Cornbelt Gardian and $8\frac{1}{2}$ pounds of AMS.

5 gallon of Cornbelt Gardian Plus per 100 gallons of spray delivers 4 quarts of Cornbelt Gardian and 17 pounds of AMS.

When using off-center tips, or when spray pressures exceed 35 psi, the addition of Cornbelt Gardian Concentrate at a rate of 1 quart per 100 gallons of water will provide additional drift management performance.

AIR:

2.5 gallon of Cornbelt Gardian Plus per 100 gallons of spray delivers 2 quarts of Cornbelt Gardian and $8\frac{1}{2}$ pounds of AMS.

5 gallon of Cornbelt Gardian Plus per 100 gallons of spray delivers 4 quarts of Cornbelt Gardian and 17 pounds of AMS.

When nozzles are oriented in a 45 degree-back configuration, the addition of Cornbelt Gardian Concentrate at a rate of 1 quart per 100 gallons of water will provide additional drift management performance.

For all applications: Do not substitute Cornbelt Gardian Plus for water required by the label.
