DUPONT™ EXPRESS® Herbicide (with TotalSol® soluble granules) at 0.4 to 0.5 oz/a can be tank mixed with DUPONT™ GR1™ herbicide at 2.0 oz/A, or “Powerflex HL” at 2 oz/A, or “GoldSky” at 1 pt/A, or “Everest 2.0” or “Sierra” at 0.5 to 1.0 fl oz/A, or “Huskie Complete” at 13.7 fl oz/A or “Rimfire Max” at 3 oz/A for yellow and green foxtail suppression in wheat.

ADJUVANTS

When EXPRESS® is used in a tank mix with DUPONT™ GR1™ herbicide, “Powerflex HL”, “GoldSky”, “Everest 2.0”, “Sierra”, “Huskie Complete” or “Rimfire Max” use the adjuvants recommended for use with the Group 2 grass herbicide from that product’s directions for use.

Antifoaming agents may be used if needed.

Do not use low rates of liquid nitrogen fertilizer solution as a substitute for surfactant.
