Grapes	5.0 – 10.3 fl oz/A (0.048 – 0.10 lb ai/A)	<ul style="list-style-type: none"> Do not apply more than 10.3 fl oz of product (0.10 lb ai) per acre per application. Do not apply more than 10.3 fl oz product (0.10 lb ai) per acre per season. Refer to the maximum usage tables on the EPA registered Hero[®] Insecticide (EPA Reg. No. 279-3315) label when applying more than one product containing either zeta-cypermethrin or bifenthrin to this crop. Do not make applications less than 7 days apart. Do not apply within 30 days of harvest.

Use Directions:

Spray in sufficient water to provide thorough coverage for best control.

Application by ground: Apply in a minimum of 25 gallons of finished spray per acre.

Application by air: Apply in a minimum of 10 gallons of finished spray per acre.

REMARKS:

Thorough coverage is essential to achieve control. Multiple applications may be required to



maintain control and prevent reinfestation from migrating adults into the crop. Spotted lanternflies are mobile and may reinfest crops quickly. If another treatment is needed before the minimum retreatment interval, use another insecticide to maintain control.
