#### **UPBEET® plus Glyphosate or UPBEET® plus Glyphosate plus Clopyralid**

A tank mixture of UPBEET® at 1.0 ounce per acre plus glyphosate may be applied as a postemergence treatment in Roundup Ready sugar beets. The addition of UPBEET® to clopyralid at 1.3 to 2.0 ounces per acre plus a glyphosate only program can provide improved control of wild buckwheat, common lambsquarters, common mallow, common ragweed, redroot pigweed, velvetleaf, volunteer Roundup Ready canola and volunteer Roundup Ready soybean. For best control of these species, make two applications of this tank mix treatment beginning when weeds are small. Applications can be applied beginning at the cotyledon sugar beet stage, with the second application applied 10 to 14 days later depending on weed size.

The addition of an adjuvant such as an MSO based high surfactant oil concentrate (HSMOC) adjuvant is recommended (such as "Destiny" HC, "Savy" and others) and should be added at 1.0 pint per acre to UPBEET® plus glyphosate tank mixes (including clopyralid at up to 2.0 oz/acre).

Ammonium sulfate (AMS) should also be added to this tank mix if it is recommended on the glyphosate label. See glyphosate label for specific AMS recommendations.

Refer to the glyphosate label for further application information and use restrictions. Follow the label guidelines that are the most restrictive.

Do not apply more than 2.5 ounces of UPBEET® per acre per season. Apply UPBEET® no later than 60 days before harvest.

### Mixing Instructions

1. Fill the tank 1/4 to 1/3 full of water.
2. Add UPBEET® with the agitator running. Continue agitation until UPBEET® is fully dispersed, at least 5 minutes. UPBEET® should be thoroughly mixed with water before adding any other material.
3. As the tank is filling, add glyphosate and clopyralid. If needed, add AMS next and then adjuvant last.
4. Triple rinse all empty containers and add rinsate to the spray tank
5. If the mixture is not continuously agitated, settling will occur. If settling occurs, thoroughly re-suspend the mixture by running the agitation system at full flow for at least five minutes before spraying.
6. If UPBEET® and glyphosate or UPBEET® and glyphosate and clopyralid are to be applied in multiple loads, pre-slurry UPBEET® in clean water prior to adding to the tank. This will prevent the tank mix partner from interfering with the dispersion of UPBEET®.
