Directions for Use: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Follow all applicable directions, restrictions, Worker Protection Standard requirements and precautions on the EPA registered label. This labeling must be in the possession of the user at the time of pesticide application. This Section 24(c) SLN label contains new or supplemental instructions for use of this product, in Wisconsin, which do not appear on the EPA-registered label. Follow the instructions carefully.

Do not apply Linex 4L to the following soils if the depth to groundwater is 30 feet or less:

- Sand with less than 3% organic matter
- Loamy sand with less than 2% organic matter
- Sandy loam with less than 1% organic matter

Do not apply Linex 4L in any manner that would contaminate irrigation water used for crops other than corn or water used for domestic purposes.

Do not apply Linex 4L within 150 feet of any well where depth to groundwater is 30 feet or less.

Do not spray over top of emerged potatoes.

Preemergence Application: Make a single application as a broadcast spray after planting but before ground cracking or crop emergence. Apply up to 1 pt. per acre when tank mixing LINEX[®] 4L with another approved herbicide or up to 2 pts. per acre when LINEX[®] 4L is applied alone. When tank mixing LINEX[®] 4L Herbicide with any other approved pesticide, always read and follow all use directions, restrictions, and precautions of both LINEX[®] 4L Herbicide and the tank mix partner(s).

Plant potato seed at least 2 inches deep. If beds are to be dragged and/or hilled, apply after the final dragging or hilling operation. Apply before grasses are 2 inches tall and before broadleaf weeds are 6 inches tall, preferably just before or when weed seedlings emerge. If emerged weeds are present, add 1 pt. surfactant for each 25 gals. spray mixture.

In irrigated areas, best results are obtained when application is made to moist soil, followed within 2 weeks by sprinkler irrigation (or rainfall). On powder dry soils, irrigate prior to herbicide application and follow with sprinkler irrigation to activate the herbicide.

Environmental Hazards

- It is a violation of federal law to harm an endangered species.
