### DIRECTIONS FOR USE

Timothy	Cereal Rust Mite	2 – 3 pts/A	Apply with ground equipment only with adequate water for complete coverage (10–50 gallons by ground). Higher water volumes should be used for improved mite control. Apply at approximately 4 weeks after green-up in the Spring. This usually occurs around early to mid April in the central and western counties of Maryland where most of the Timothy is grown. Treatment is recommended in fields with previous history of cereal rust mite and/or when 25% of the plant tillers exhibit curled tips of the new leaf blades within several weeks of green-up. In general, one application at 2–3 pts. per acre should provide control.

### RESTRICTIONS AND PRECAUTIONS: TIMOTHY

- Do not apply more than once per cutting.
- Do not apply within 30 days of harvest or grazing.
- Do not exceed 3 pints per acre per cutting.
