DUPONT™ SENTRALLAS™ Herbicide at 8 to 11 fluid ounces per acre can be tank mixed with “Varro” herbicide at 6.85 fluid ounces per acre for control of barnyardgrass, green foxtail, wild oat, and yellow foxtail when these grasses are treated between 1-leaf to 2 tiller stage of growth. Winter wheat and spring wheat should be in the 2-leaf stage, but before the flag leaf is visible.

When SENTRALLAS™ Herbicide is used in a tank mix with “Varro” herbicide, use the adjuvants recommended for use with each product’s directions for use.
