For dry fertilizer applications, use LS line of granular micronutrients.

Apply 1-6 quarts of CITRI-CHE® ZINC 10% COMPLETE per acre in liquid starter fertilizer. Rate will depend upon extent of the zinc deficiency and soil conditions.

For Use In Wisconsin – Use 0.5 - 1 lb/acre of zinc chelate in a band or 1-2 lbs/acre of zinc chelate in a broadcast application. Deficiencies may also be corrected by using 0.15 lbs/acre of zinc chelate as a foliar application.

Solid Set, Overhead, Sprinkler or Pivot Irrigation Systems: Apply CITRI-CHE® ZINC 10% COMPLETE at 2 to 4 qts per acre. Use of anti-siphon or back-check valve is recommended to prevent material from running back into primary water supply.
