## **GENERAL INFORMATION**

**OnTarget™** is a unique spray adjuvant, specifically designed to maximize pesticide performance when applying pesticides through nozzles that are classified to produce extremely-coarse and ultra-coarse droplet spectrums. **OnTarget™** reduces the amount of spray droplets that have a high potential to move off target in a ground application. **OnTarget™** should be used in conjunction with proper spray equipment selection, set-up, and use including boom height, nozzle type, size and pressure. Along with good judgment and the proper selection and use of spray equipment, **OnTarget™** can help professional applicators ensure the maximum performance of pesticides.

## **DIRECTIONS FOR USE**

**OnTarget™** may be used when spraying pesticides in a ground application through nozzles that deliver a droplet spectrum that is categorized as extremely and ultra coarse.

### **Rates of application**

**OnTarget™** may be used at a rate of 0.5% v/v.

### **Mixing Instructions**

**Add OnTarget™** after wettable powders, dry flowables, liquid flowables, and suspensions but before emulsifiable concentrates and other adjuvants. Agitate after adding **OnTarget™** for five minutes before beginning spray application. Follow specific tank mix filling and mixing information provided on the herbicide label. Refer to other pesticide labels for additional recommendations or precautions.

Before mixing pesticides with **OnTarget™**, conduct a jar test to determine compatibility.

**DO NOT use OnTarget™ through a direct injection system.**
