CORNBELT® EN-PACK™ is a water conditioning agent designed for use with glyphosate alone, glyphosate tank mixes containing 2,4-D esters or choline salts of 2,4-D, and glyphosate tank mixes with other pesticides. CORNBELT® EN-PACK™ contains a special phosphate amine surfactant specifically designed to improve the performance of glyphosate. CORNBELT® EN-PACK™ is designed for use with nozzles which deliver coarse spray droplets such as AI & Turbo-T nozzles. CORNBELT® EN-PACK™ is designed to not interfere with proper nozzle function needed for drift mitigation while providing increased coverage by increased spreading on the leaf surface to promote enhanced 2,4-D activity. CORNBELT® EN-PACK™ contains a high technology defoaming system to control foaming in the spray tank.

DIRECTIONS FOR USE

CORNBELT® EN-PACK™ is intended for use with products registered for agricultural, horticultural, turf, ornamental, industrial, and non-crop uses.

WARNING: Read and follow all pesticide label directions. Do not use where the pesticide label specifically prohibits the use of an adjuvant. If the pesticide label neither recommends nor prohibits an adjuvant, the applicator must have previous experience with the adjuvant/pesticide spray mixture or should apply a small test area before making large scale applications. USE RATE: Use CORNBELT® EN-PACK™ at 2 to 4 quarts per 100 gallon of spray solution based on water hardness.

MIXING: Add CORNBELT® EN-PACK™ prior to adding the herbicide(s) to the spray mix.
