#### PRODUCT INFORMATION

VINCERO™ 90 is a general purpose low foam non-ionic surfactant and humectant used to improve the effectiveness of pesticides. VINCERO 90 improves pesticide performance by increasing spray coverage on target leaf surfaces. It is designed for quick wetting, uniform droplet distribution and increased spray retention on leaf and stem surfaces.

## DIRECTIONS FOR USE

The spreading effect of VINCERO 90 will vary based on various factors. Use only the minimum amount of VINCERO 90 to obtain a smooth and uniform film on the plant surface. Care must be taken when applying to crops during periods when plants are subjected to drought stress, high temperatures and high humidity.

Use 8-64 fluid ounces of VINCERO 90 per 100 gallons of spray mixture. Always follow the adjuvant use recommendations as shown on the pesticide label.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

**STORAGE:** Store in original container only and keep tightly sealed. Store in closed storage area.
