4. FIRST AID MEASURES

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. 6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this MSDS. Control spill at the source and prevent material from entering soil, sewers, waterways or low areas. If necessary, dike spill using absorbent or impervious materials such as clay or sand. Recover materials for reuse or disposal by pumping any free liquid into appropriate closed containers, do not flush to drain.

7. HANDLING AND STORAGE
