**4. FIRST AID MEASURES**

**If in Eyes:** Hold eye open and rinse slowly and gently with water. Remove contact lenses, if present, then continue rinsing eye. Get medical attention if irritation occurs and persists.

**If Swallowed:** Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person. If symptoms develop, get medical advice.

**If Inhaled:** Move person to fresh air. If breathing is difficult, administer oxygen. If symptoms develop, get medical advice.

**If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water. If irritation occurs, get medical advice.

**Most important symptoms/effects, acute and delayed:** Causes eye irritation.

**Indication of immediate medical attention and special treatment needed, if necessary:** Immediate medical attention should not be required.

**5. FIRE FIGHTING MEASURES**

**Extinguishing Media:** Recommended for large fires: foam or water spray. Recommended for small fires: dry chemical or carbon dioxide.

**Special Fire Fighting Procedures:** Firefighters should wear NIOSH approved self-contained breathing apparatus and full fire-fighting turn out gear. Dike area to prevent runoff and contamination of water sources. Dispose of fire control water later.

**Unusual Fire and Explosion Hazards:** If water is used to fight fire, contain runoff, using dikes to prevent contamination of water supplies. Dispose of fire control water later.

**Hazardous Decomposition Materials (Under Fire Conditions):** May produce gases such as hydrogen chloride, organochlorine products, and oxides of carbon and nitrogen.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal Precautions:** Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

**Environmental Precautions:** Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

**Methods for Containment:** Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

**Methods for Cleanup and Disposal:** Pump any free liquid into an appropriate closed container. Collect washings for disposal. Decontaminate tools and equipment following cleanup. See Section 13: DISPOSAL CONSIDERATIONS for more information.

**Other Information:** Large spills may be reportable to the National Response Center (800-424-8802) and to state and/or local agencies.

**7. HANDLING AND STORAGE****HANDLING:**

Avoid contact with eyes or clothing. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment (PPE) immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:**

Store in original container in a well-ventilated area separately from fertilizer, feed and foodstuffs. Avoid cross-contamination with other pesticides. Spillage or leakage should be contained and absorbed with clay granules, sawdust, or equivalent material for disposal. Do not contaminate water, food or feed by storage and disposal.

**8. EXPOSURE CONTROLS / PERSONAL PROTECTION****Engineering Controls:**

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

**Personal Protective Equipment:**

**Eye/Face Protection:** Not normally required. To avoid contact with eyes, wear chemical goggles or shielded safety glasses. An emergency eyewash or water supply should be readily accessible to the work area.

**Skin Protection:** To avoid contact with skin, wear long pants, long-sleeved shirt, shoes plus socks, and chemical-resistant gloves. An emergency shower or water supply should be readily accessible to the work area.

**Respiratory Protection:** Not normally required. If vapors or mists exceed acceptable levels, wear NIOSH approved air-purifying respirator with cartridges/canisters approved for use against pesticides.

**General Hygiene Considerations:** Personal hygiene is an important work practice exposure control measure and the following general measures should be taken when working with or handling this material: 1) do not store, use and/or consume foods, beverages, tobacco products, or cosmetics in areas where this material is stored; 2) wash hands and face carefully before eating, drinking, using tobacco, applying cosmetics or using the toilet.

## 10. STABILITY AND REACTIVITY

**Reactivity:** Not reactive.

**Chemical Stability:** This material is stable under normal handling and storage conditions.

**Possibility of Hazardous Reaction:** Hazardous polymerization will not occur.

**Conditions to Avoid:** Excessive heat. Do not store near heat or flame.

**Incompatible Materials:** Strong oxidizing agents: bases and acids.

**Hazardous Decomposition Products:** Under fire conditions may produce gases such as hydrogen chloride, organochlorine products, and oxides of carbon and nitrogen.

## 11. TOXICOLOGICAL INFORMATION

**Likely Routes of Exposure:** Inhalation, eye and skin contact.

**Symptoms of Exposure:**

**Eye Contact:** Causes eye irritation. Vapors and mists can cause irritation.

**Skin Contact:** Mildly irritating based on toxicity studies.

**Ingestion:** Ingestion may cause nausea, vomiting, and abdominal pain.

**Inhalation:** May cause upper respiratory tract irritation, coughing, or wheezing.

**Delayed, immediate and chronic effects of exposure:** None known.

**Toxicological Data:**

Data from laboratory studies on this product are summarized below:

**Oral:** Rat LD<sub>50</sub>: >5,000 mg/kg (females)

**Dermal:** Rat LD<sub>50</sub>: >5,000 mg/kg

**Inhalation:** Rat 4-hr LC<sub>50</sub>: >2.02 mg/L (no mortalities at highest tested dose)

**Eye Irritation:** Rabbit: Mildly irritating

**Skin Irritation:** Rabbit: Slightly irritating (PDII=1.7)

**Skin Sensitization:** Not a contact sensitizer in guinea pigs following repeated skin exposure.

**Subchronic (Target Organ) Effects:** Repeated overexposure to dicamba may cause liver changes or a decrease in body weight.

**Carcinogenicity / Chronic Health Effects:** Dicamba did not cause cancer in long-term animal studies. The U.S. EPA has given dicamba a Class D classification (not classifiable as to human carcinogenicity).

**Reproductive Toxicity:** Dicamba did not interfere with fertility in reproduction studies in laboratory animals.

**Developmental Toxicity:** Animal tests with dicamba have not demonstrated developmental effects.

**Genotoxicity:** In vitro and in vivo animal tests with dicamba did not demonstrate mutagenic effects.

## 12. ECOLOGICAL INFORMATION

**Environmental Fate:**

Dicamba poorly binds to soil particles, is potentially mobile in the soil and highly soluble in water. Aerobic soil metabolism is the main degradative process for dicamba with a typical half-life of 2 weeks. Degradation is slower when low soil moisture limits microbe populations. In water, microbial degradation is the main route of dicamba dissipation. Aquatic hydrolysis, volatilization, adsorption to sediments, and bioconcentration are not expected to be significant.

## 13. DISPOSAL CONSIDERATIONS

**Waste Disposal Method:**

Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.

**Container Handling and Disposal:**

**Nonrefillable Containers 5 Gallons or Less:** Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying.

**Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers are also disposable by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

**Nonrefillable Containers Larger than 5 Gallons:** Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

**Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

**Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

**Refillable Container Larger than 5 Gallons:** Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10% full with water and, if possible, spray all sides while adding water. If practical, agitate vigorously or recirculate water with the pump for two minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.

**Refillable Container:** Refill this container with pesticide only. Do not reuse this container for any other purpose. Close all openings and replace all caps. Contact Nufarm's Customer Service Department at 1-800-345-3330 to arrange for return of the empty refillable container.
