GENERAL INFORMATION

Amsol is a 34.0% liquid ammonium sulfate solution designed to increase herbicide performance through:

- Increased absorption into the plant's phloem through the leaf cuticle
- Decreased herbicide antagonism due to calcium ion mineralization

DIRECTIONS FOR USE

Prior to use read and follow all directions on this label and on the label of the tank mix partner(s). The tank mix partner's label(s) for specific usages and restrictions have precedence over the DIRECTIONS FOR USE referred to on this label.

Mixing Instructions:

SHAKE WELL OR RECIRCULATE BEFORE USE

1. Fill sprayer 1/3 to 1/2 full of water
2. Add Amsol to the agitating spray tank
3. Add dry flowables or dispersable granules
4. Add emulsifiable concentrates
5. Continue to agitate until tank is full

Recommended Rates

Each gallon of Amsol contains 3.4 pounds of ammonium sulfate. To meet various label recommendations, include:

- 2.5 gallons of Amsol per 100 gallons to equal 8.5 pounds of ammonium sulfate per 100 gallon.
- 3 quarts per acre of Amsol to equal 2.5 pounds of ammonium sulfate per acre.

1.2 quarts of Amsol is equal to 1 pound of ammonium sulfate.
