DIRECTIONS FOR USE:

To control Lygus Bugs, Weevils, Aphids and Spider Mites, apply Brigade 2EC at the rate of 3.9 to 6.4 ounces (0.06 to 0.1 lb. active) per acre. Apply in a minimum of 5 gallons of water per acre by air equipment or a minimum of 20 gallons of water per acre by ground equipment. When applying by air, 1 quart of emulsified oil may be substituted for 1 quart of water in the finished spray.

RESTRICTIONS:

Do not use more than 19.2 ounces (0.3 lb. active) per season.

Rotational crops may be planted no sooner than 30 days after last application.

Do not apply Brigade 2EC or allow it to drift to blooming crops or weeds while bees are actively visiting the treatment area.

Do not apply Brigade 2EC when weather conditions would favor drift or run-off from a proposed treatment site into fish bearing waters.

Do not graze or cut current year's treated Alfalfa Seed crop for hay or forage.
