DIRECTIONS FOR USE:

Chemigation Use: Apply at or near corn rootworm egg hatch in a minimum of 0.75 -1.0 inches of irrigation water per acre using overhead, sprinkler irrigation. Applications soon after rootworm feeding has initiated will have best results. Rescue applications that are made after significant root feeding and damage has occurred, may not prevent root lodging or allow time for root re-growth to occur. Do not apply to soils that are saturated or near saturation with water to prevent runoff and allow irrigation water to move into the soil profile to distribute product in the root zone.

RESTRICTIONS:

- Do not apply more than 0.3 lb ai/A per season including all at-plant and foliar applications.
- Do not harvest for grain, graze livestock in treated areas, or cut treated crops for feed within 30 days of last application.
