- Do not apply more than 19.2 fl. oz./A of BRIGADE® 2EC insecticide or 0.3 lb ai/A of bifenthrin-containing products per calendar year.
- Apply in a minimum of 3 GPA (aerial) and 10 GPA (ground) for optimal coverage and efficacy.
- Application by chemigation systems is allowed.
- The REI is 12 hours.
- Interval between last application and harvest is 30 days.

BRIGADE® 2EC insecticide may be mixed with adjuvants, fungicides, or herbicides to provide disease or weed control and insect management in one application.
