Soybeans	Soybean Gall Midge (<i>Resseliella maxima</i>)	5.0 to 10.3 fl. oz./A (0.05 to 0.10 lb. ai/A)

DIRECTIONS FOR USE:

Apply to soybeans by ground or air equipment using sufficient water to obtain full coverage of foliage (minimum of 10 gallons by ground and 2 gallons by air) when adult flies begin to emerge. Use higher use rates if field is located adjacent to previously infested areas and conditions are favorable for adult flight. Thorough coverage is essential to achieve control. Apply as required by scouting. Timing and frequency of applications should be based upon insect populations reaching locally determined economic threshold levels. Under heavy outbreak conditions HERO insecticide may be tank-mixed with other insecticides for broader spectrum control and improved resistance management.

RESTRICTIONS:

- Do not apply more than 10.3 fl. oz./A (0.10 lb. ai/A) per application.
- Do not apply more than 41.2 fl. oz./A (0.40 lb. ai/A) per season.
- Do not graze or harvest treated soybeans forage, straw, or hay for livestock feed.
- **PHI:** Do not apply within 21 days of harvest.
- **Restricted-entry Interval (REI):** 12 Hours
- Do not make applications less than 30 days apart.
