DIRECTIONS FOR USE:

- Apply in the spring or fall to stubble of harvested crops or fallow ground for control of weeds prior to emergence in no-till or conservation tillage systems.
- Apply Authority MTZ DF as a broadcast spray with either ground or aerial application equipment. Use a minimum of 10 gallons per acre by ground or 5 gallons per acre by aerial application.
- For fall applications, apply after October 15 when soil temperatures are 55° F or below at the 4 inch soil depth.
- Authority MTZ DF may be tank-mixed with other herbicides labeled for use in fallow or eco-fallow applications. The addition of atrazine at 0.5-1.0 lb a.i./acre can improve residual control of some weed species.
- Tank-mix a labeled burndown herbicide such as Aim®, 2,4-D, dicamba, Gramoxone®, or Roundup® for control of emerged broadleaf or grass weeds.
- Follow all label use directions, rotational guidelines and restrictions for Authority MTZ DF and any tank-mix partners and use the most restrictive guidelines.
- The following crop rotations must be followed. For all other crops, refer to the EPA registered label.

¹ Field Corn includes corn grown for grain, forage or silage, and seed corn.
² Sorghum may be planted after 12 months where Authority MTZ DF was applied at 20 oz/acre or less in the previous cropping season.
³ Crops that have rotational intervals greater than 12 months after an Authority MTZ DF application are the result of crop injury concerns.
⁴ Field corn may be planted after 4 months where Authority MTZ DF was applied at 14 oz/acre or less in the previous cropping season.

RESTRICTIONS:

- Do not apply to frozen soils.
- Do not apply more than a total of 22 oz/acre Authority MTZ DF (0.25 lb ai sulfentrazone and 0.37 lb ai metribuzin) as a fallow application per year. Do not apply more than a total of 0.375 lb ai of sulfentrazone per year or 1.2 lb ai of metribuzin per year.
- Do not apply to soils classified as sand, with less than 1% organic matter.
