#### **GENERAL INFORMATION**

Noble<sup>®</sup> is a multi-component spray adjuvant developed to maximize the performance of certain herbicides and insecticides in postemergent applications. This product is a replacement for non-ionic surfactants and crop oils (petroleum oils) in spray mixtures. Noble<sup>®</sup> has been widely tested and research indicates improved performance and consistency when combined with certain herbicides and insecticides.

**Environmental Hazards**: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water sources with equipment wash water, spray disposal wastes or by cleaning of equipment.

#### SHAKE WELL BEFORE USE.

Use Noble<sup>®</sup> at 1.0 to 2.0 pints per acre with postemergent herbicides. The 2.0 pints per acre rate may be required if weed populations are extreme or if plants are stressed at the time of treatment. Noble<sup>®</sup> may be used at 1.0 to 2.0 pints per acre with insecticides, or at a final solution concentration of 0.125% to 1.00% (1 pint to 4 quarts per 100 gallons). Always add Noble<sup>®</sup> last to the spray mix and continue agitation or follow specific tank filling and mixing information provided on the pesticide label.

**Special Caution:** Noble<sup>®</sup> increases the effectiveness of herbicides. During periods of high temperatures or extremely humid conditions, herbicides become more active. It is recommended that a small test area be treated if such conditions prevail. Test areas are also recommended before treating new crop varieties or highly inbred crop lines.

#### STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry, well-ventilated area away from children, animals, food and feed products. Store in original container only. Keep containers tightly closed when not in use. Take care to prevent water from being introduced to the contents of this container. Do not use or store near open flame. Protect from freezing. If Noble<sup>®</sup> is stored below 32°F, it may become cloudy and thicken. Noble<sup>®</sup> should return to it's normal, clear fluid state above 32°F.
