Directions for Use:

Apply as required by scouting. Timing and frequency of applications should be based upon insect populations reaching locally determined economic threshold levels. Do not exceed the maximum allowable rate.

Apply by ground or air equipment using sufficient water to obtain full coverage of foliage. For ground application, use a minimum of 20 gallons finished spray per acre for concentrate spray or a minimum of 100 gallons finished spray per acre for dilute spray. For air application use a minimum of 10 gallons finished spray per acre.

Restrictions:

- Do not apply this product until after petal fall.
- Do not apply more than 24 fl oz/A/year (0.15 lb ai/A/year).
- Do not apply as a ULV spray.
- Do not make applications less than 7 days apart.
- Do not feed or allow livestock to graze on cover crops from treated orchards.
- Do not apply within 3 days of harvest.
- Do not allow entry into treated areas for 12 hours following application.
