SPINACH: Apply a surface broadcast application with ground application equipment prior to planting. Apply 1/2 to 2/3 gallons RO-NEET HERBICIDE (3 to 4 lbs. ai} per acre on sandy mineral soils only in a minimum of 20 gallons of water per acre. Immediately after application, thoroughly mix RO-NEET HERBICIDE into the soil to a depth of 2 to 3 inches using a finishing disk, harrow, rolling cultivator or similar implement capable of providing uniform incorporation. For applications after planting immediately incorporate with sprinkler irrigation.
