**SPINACH:** Apply a surface broadcast application with ground application equipment prior to planting. Use on sandy mineral soils only. Apply 0.34 to 0.50 gallons RO-NEET HERBICIDE (2 to 3 lbs. ai) per acre in a minimum of 20 gallons of water per acre. Immediately (i.e. within minutes) after application, thoroughly mix RO-NEET HERBICIDE into the soil to a depth of 2 to 3 inches using a finishing disk, harrow, rolling cultivator or similar implement capable of providing uniform incorporation.

**WEEDS CONTROLLED:** See WEEDS CONTROLLED and PERENNIAL WEEDS tables on the label affixed to the main container of RO-NEET HERBICIDE.

**RESTRICTIONS:**

- Do NOT harvest spinach for 45 days following application of this product.
- Do NOT apply this product through any type of irrigation system.
- Do NOT apply this product by aerial application.
- Do NOT make more than one (1) application per year.
