Hops	Halo Blight caused by <i>Diaporthe humulicola</i>	7 fl. oz./acre (0.114 lb. ai/acre)	Apply preventatively or when conditions are favorable for disease development. Repeat as necessary if conditions remain favorable for disease development. Apply a minimum of 30 gallons per acre spray volume for ground applications and 10 gallons per acre spray volume for aerial applications.	14

Restrictions:

- No single application may exceed 7 fl. oz. of product (0.114 lb. ai)/A.
- The minimum retreatment interval is 14 days.
- **DO NOT** apply more than 4 applications per year.
- **DO NOT** apply more than 28 fl. oz. of product (0.455 lb. ai)/A per year.
- **DO NOT** apply more than 0.455 lb. ai of Flutriafol/A per year.
- An adjuvant may be used with RHYME® Fungicide.
- Restricted Entry Interval (REI) is 12 hours.
- Preharvest Interval (PHI): **DO NOT** apply within 7 days of harvest.

All applicable directions, restrictions, and precautions on the Rhyme® Fungicide Label (EPA Reg. 279-3588) must be followed. This recommendation should be in possession of the user at the time of pesticide application.
