## **Directions For Use**

Apply Topguard<sup>®</sup> fungicide in the fall and/or early spring from tillering to jointing growth stages (Feekes stages 3-7) to provide protection against early season leaf diseases. Topguard fungicide may be tankmixed with adjuvants, fertilizer, insecticides (such as **Mustang<sup>®</sup> MAXX** insecticide) or herbicides (such as **Harmony<sup>®</sup> Extra SG** herbicide with TotalSol<sup>®</sup> soluble granules or **Finesse<sup>®</sup>** Cereal and Fallow herbicide) to implement disease, insect and weed management. An application of Topguard<sup>®</sup> EQ fungicide may be applied at flag leaf (Feekes 8-9) for control of foliar diseases as specified by product labels. Apply in a minimum of 2 gallons per acre for aerial application and 10 gallons per acre by ground application.

## **RESTRICTIONS:**

- Do not apply more than 2 applications per year.
- Do not apply more than 0.228 lb. ai of flutriafol/A per year.
- Restricted entry interval (REI) is 12 hours.
- Preharvest Intervals (PHI): Do not apply within 30 days of harvest when grown for grain, 15
- days of harvest when grown for hay, zero (0) day PHI when grown for forage
