Zidua SC is a selective rate-dependent residual preemergence herbicide for controlling annual grasses, sedges, and annual broadleaf weeds. Refer to the **Zidua SC** container label for a complete list of weeds controlled.

Application Rate

Apply **Zidua® SC herbicide** in cotton at the residual rates provided in **Table 1**.

Early Postemergence Application

Apply **Zidua SC** at use rates specified in **Table 1** as a broadcast spread of impregnated dry bulk fertilizer to cotton from 2-leaf stage to beginning bloom stage.

Apply a minimum of 250 pounds of dry bulk fertilizer per acre to ensure sufficient broadcast coverage for effective weed control. Further increasing the rate of fertilizer spread per acre can improve soil surface coverage and weed control.
