GENERAL INFORMATION

Permeate is a high-quality non-ionic surfactant and humectant that improves wetting, spreading and dispersing of the spray solution on target surfaces. Permeate has odor control. The addition of Permeate non-ionic surfactant to the spray solution will reduce the surface tension of spray droplets, to aid in pesticide absorption by leaves and foliage. Permeate is nonylphenol ethoxylate (NPE) free and designed to be used with all pesticides.

DIRECTIONS FOR USE

Permeate may be used whenever a pesticide label allows for the addition of a non-ionic surfactant. Prior to use, read all directions on this label and on the label of the pesticide or other agricultural product used. Follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Rate of Application

For most applications use 0.25% v/v or 1 quart per 100 gallons with herbicides, insecticides and fungicides.

Other suggested rates for use with various categories of chemicals as follows:

Chemical Group	Pints of Permeate to add per 100 gallons of spray mixture
Insecticides, Miticides & Fungicides Fertilizers and Micronutrients	0.5 to 2
Herbicides, Defoliant and Desiccants	1 to 4

Mixing Instructions

Add Permeate to the spray tank after all other products have been included.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a dry, cool and well-ventilated place, away from children, food and feed products. Store product in original container only. Keep this container closed when not in use. Do not allow other chemicals to be introduced into the container. STORAGE ABOVE 40°F is recommended. If product is stored below 40°F, warm and agitate (recirculate) prior to use.

Disposal: Do not reuse container. Dispose of contents/container in accordance with Federal, state and local regulations. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
