DIRECTIONS FOR USE:

Apply Lucento® fungicide in early spring from tillering to jointing growth stages (Feekes stages 3-7) to provide protection against listed early season leaf diseases. Lucento fungicide may be tank-mixed with adjuvants, fertilizer, insecticides (such as **Mustang® MAXX*** insecticide) or herbicides (such as **Harmony® Extra SG** herbicide with TotalSol® soluble granules or **Finesse®** Cereal and Fallow herbicide) to implement disease, insect and weed management. An additional application of Lucento fungicide may be required at flag leaf (Feekes 8-9) to provide full season control of foliar diseases as specified by product labels. Apply in a minimum of 2 gallons per acre for aerial application and 10 gallons per acre by ground application.

RESTRICTIONS:

- Do not apply more than 2 applications per year.
- Do not apply more than 0.228 lb. ai of flutriafol/A per year.
- Do not apply more than 0.132 lb. ai of bixafen per acre per year.
- Restricted Entry Interval (REI) is 12 hours.

Preharvest Intervals (PHI): Do not apply within 30 days of harvest when grown for stover, forage, or grain.
