Directions For Use

Apply at the onset of disease or when conditions are conducive for aerial web blight infection in soybean. A second application may be applied if needed to maintain agronomically acceptable disease control.

RESTRICTIONS:

- Maximum of 2 applications at the highest use rate (11 fl oz of product/A per year) or 3 applications at a lower rate (9 fl oz of product/A per year).
- DO NOT apply more than 11 fl oz of product/A per year.
- DO NOT apply more than 0.488 lb ai of flutriafol/A per year from all flutriafol containing products.
- DO NOT apply more than 0.132 lb ai of bixafen/A per year from all bixafen containing products.
- Restricted-entry interval (REI) = 12 hours.
- LUCENTO fungicide may be applied up to 21 days before harvest.
- DO NOT feed hay or threshings or allow livestock to graze in treated areas.
- Not registered for use in California.
