STORAGE AND DISPOSAL

Storage: Storage above 32° F is recommended. However, if product is allowed to freeze, warm and agitate (recirculate) prior to use. Store in a secure, cool, dry and well-ventilated area away from children, food and feed products. Store away from open flames, hot surfaces and sources of ignition. Keep container tightly closed when not in use. Store in original container only.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. GENERAL INFORMATION

Double X is a convenient premix product containing drift reduction technology (DRT) adjuvants & non-AMS water conditioner. This combination of ingredients helps reduce drift and off-target movement while also improving droplet spreading and conditioning water. **Double X** helps maintain the efficacy of tank mixed herbicides.

DIRECTIONS FOR USE

Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages, rates and restrictions have precedence over DIRECTIONS FOR USE referred to on this label.

Not all combinations of **Double X** and other products have been tested on all crops and for all uses. These tank mixes should be tested on a small portion of the field to ensure product compatibility and crop safety prior to general use.

For use with pesticides registered for agricultural, forestry, industrial, municipal, non-cropland and rights-of-way. Not for aquatic use.

Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high-water mark.

RECOMMENDED USE RATES

Mix 0.5%-0.75% v/v of **Double X** per 100 gallons of spray solution.

MIXING

Before mixing pesticides with **Double X**, conduct a jar test to determine compatibility.

Add **Double X** after pesticides or other adjuvants are added but prior to complete filling of the spray tank.

Consult the tank mix partner labels for further information on mixing.
