Application Rates, Timing, Method and Pest Controlled

EXIREL® insect control is recommended for control of Allium leafminer (*Phytomyza gymnostoma*). Apply EXIREL insect control at 13.5 – 20.5 fl oz/A (0.088 – 0.133 lb ai/A) as a foliar spray.

Initiate foliar applications based on the presence of adult flies or when the initial oviposition marks are observed on crop foliage. Follow local university recommendations for treatment thresholds and optimum application timing.

Thorough spray coverage is essential for best performance. Use a minimum of 10 gal by ground or 5 gal by air. Spray volumes of 15 gal per acre and higher by ground generally improve coverage and insect control.

Use of adjuvants with EXIREL insect control has been shown to improve spray coverage and increase efficacy. Select adjuvants based on experience and known crop safety. If crop safety is unknown, use on a small area before treating larger areas. Refer to the *Tank Mixtures and Crop Safety* section of the EXIREL insect control label for additional information regarding tank mixtures.

EXIREL insect control may be applied by overhead chemigation to bulb vegetables. Refer to the *CHEMIGATION – Overhead Sprinkler* section of the EXIREL insect control label for additional application instructions.

SPRAY PREPARATION

Acidification of spray tank: If the pH of the spray tank after all products have been added and mixed is above pH 8, then adjust to pH 8 or less using a registered acidifying agent. If the spray tank is 8 or less, no adjustment is necessary. Spray tanks of pH 8 or less can be held up to 8 hours before spraying. Do not store the spray mixture overnight in the spray tank.

RESTRICTIONS AND PRECAUTIONS

- Minimum interval between treatments is 5 days.
- Do not apply a total of more than 0.4 lb ai/A Cyazypyr® active or cyantraniliprole containing products per calendar year whether applications are made to the soil or foliarly.
- The preharvest interval (PHI) is 1 day.
- The field re-entry interval (REI) is 12 hours.
