Do not apply more than 9 oz ALTACOR® insect control or 0.2 lb a.i. of chlorantraniliprole containing products per acre per calendar year.
 Do not make more than 4 applications per calendar year.
 Refer to the UC IPM Pest Management Guidelines for adult emergence monitoring using pheromone traps and degree day accumulation to determine the timing of application to first or second generation. Make the first application at initiation of egg hatch, to small larvae, or first signs of infestations. To manage resistance, target only one of the two generations with ALTACOR insect control or any other group 28 containing insecticide.
 Use higher rates of ALTACOR insect control for moderate to heavy insect pressure. Make repeat applications on 7 to 10 day schedule if monitoring indicates continued feeding activity.
 Do not apply less than 30 gal water per acre by ground.
