Sugar Beets: Control of Beet Armyworm (*Spodoptera exigua*) and Western Yellow Striped Armyworm (*Spodoptera praefica*) by Soil Shank Injection of CORAGEN insect control

DIRECTIONS FOR USE

Coragen® insect control is recommended for control of beet armyworm (*Spodoptera exigua*) and western yellow striped armyworm (*Spodoptera praefica*) by soil shank injection in sugar beets.

Apply Coragen® insect control at 3.5 - 7.5 fluid ounces per acre (0.045-0.098 lb. a.i./A) as a shank injection at planting.

For best results, apply Coragen® insect control in a manner that ensures the application is in the sugar beet root zone. Incorporate the application using sufficient irrigation (typically 0.5 to 1.0 inch of water) to reach the root zone. The shank injection should be placed in the seed row or just below the seed line, within 1-2 inches of the seed line.

FMC Corporation 2929 Walnut Street Philadelphia, PA 19104 215-299-6000 Apply higher rates within the listed rate range when pests are expected to occur later in the crop growth cycle, when heavy infestations of beet armyworms or western yellow striped armyworms occur, or when extreme environmental conditions, such as rainy weather and high temperatures, are expected.

- Do not apply Coragen® insect control within 1 day of harvest.
- o Do not enter, or allow worker entry, into treated areas during the restricted-entry (REI) of 4 hours.
- o Make no more than 4 applications of Coragen® insect control per acre per crop.
- o Do not apply more than 15.4 fluid ounces of Coragen® insect control, or 0.2 lb. a.i. of chlorantraniliprole containing products, per acre per crop.
- o Do not apply more than 61.6 fluid ounces of Coragen® insect control, or 0.8 lb a.i. of chlorantraniliprole containing products, per acre per calendar year.
