Wheat (including durum), Barley, Oat, Triticale and Fallow	Field Pansy (Johnny Jump Up) <i>Viola bicolor</i>	Apply 0.6 to 0.9 oz./A HARMONY® EXTRA SG herbicide in wheat, barley, triticale or fallow. Apply 0.6 oz./A HARMONY® EXTRA SG herbicide in oat. Two applications of HARMONY EXTRA SG herbicide may be made to wheat, barley, triticale and fallow provided the total amount applied does not exceed 1.5 oz per acre per crop season. Only one application per season at 0.6 oz./A HARMONY EXTRA SG herbicide is allowed in oat.

**DIRECTIONS FOR USE:**

HARMONY® EXTRA SG herbicide may be used for postemergence control of field pansy. In wheat, barley, winter oat, and triticale, make applications after the crop is in the 2-leaf stage, but before the flag leaf is visible. For spring oat, make application after the 3-leaf growth stage but before jointing. Rainfall immediately after treatment can wash HARMONY® EXTRA SG herbicide off weed foliage, resulting in reduced weed control. Several hours of dry weather are needed to allow HARMONY® EXTRA SG herbicide to be sufficiently absorbed by weed foliage. Always include a spray adjuvant (such as non-ionic (NIS) at 0.06 to 0.50% volume/volume (1/2 pt to 4 pt per 100 gal of spray solution) or Petroleum Crop Oil Concentrate (COC) or Modified Seed Oil (MSO) (at 1% volume/volume (1 gal per 100 gal spray solution) or 2% volume/volume under arid conditions) with applications of HARMONY® EXTRA SG herbicide. Surfactant products must contain at least 60% nonionic surfactant with a hydrophilic/lipophilic balance (HLB) greater than 12. Oil adjuvants must contain at least 80% high quality, petroleum (mineral) or modified vegetable seed oil with at least 15% surfactant emulsifiers. In addition to a spray adjuvant, an ammonium nitrogen fertilizer may be used. Refer to the federal label for further instructions, recommended spray volume, tank mix additives and surfactants.

**RESTRICTIONS:**

- Do not use with spray additives that alter the pH of the spray solution below pH 5.0 or above pH 9.0 as rapid product degradation can occur.
- Do not apply HARMONY® EXTRA SG herbicide by air in the state of New York.
- Take all necessary precautions to avoid all direct or indirect contact (such as spray drift) with non-target plants or areas.
- The total rate of HARMONY® EXTRA SG herbicide for wheat (including durum), barley, triticale and fallow cannot exceed 1.5 ounces product per acre applied to any one crop during one growing season.
- The total rate of HARMONY® EXTRA SG herbicide for oat cannot exceed 0.6 ounces product per acre applied to any one crop during one growing season.
- Do not apply to wheat underseeded with another crop.
- Do not harvest sooner than 45 days after the last application of HARMONY® EXTRA SG.
