Pepper (BELL, CHILI, COOKING, PIMENTO AND SWEET)	Foliar	Pepper weevil (<i>Anthonomus eugenii</i>)	6.0 oz/A (0.11 lb ai/A)	3	12

- AVAUNT eVo insect control is recommended as a foliar application for suppression of adult pepper weevil.
- Apply AVAUNT eVo insect control at 6.0 oz/A (0.11 lb ai/A) as part of a foliar program rotating with different mode of action insecticides known to be effective on pepper weevil.
- Spray programs should begin at flowering or at the first sign of adult weevils.
- Make repeat applications on a 5 to 7-day spray schedule if monitoring indicates the presence of adult weevils.
- See the Resistance Management section of the AVAUNT eVo insect control Section 3 Federal label for additional guidance regarding insecticide resistance management.

- Thorough coverage is essential to achieve best results. Select a spray volume appropriate for the size of plants and density of foliage being treated.

RESTRICTIONS AND PRECAUTIONS

- Do not apply more than 24 oz/A AVAUNT eVo insect control or 0.44 lb ai of indoxacarb-containing products per acre per crop.
- Do not make more than 4 applications per crop.
- Do not apply more than 72 oz/A AVAUNT eVo insect control or 1.32 lb ai of indoxacarb-containing products per acre per year.
- Apply in a minimum of 10 gallons of water per acre (GPA) by ground.
- The minimum interval between sprays is 5 days.
