DIRECTIONS FOR USE

- AVAUNT eVo insect control is recommended as a foliar application for suppression of cucumber beetles.
- Apply AVAUNT eVo insect control at 6.0 oz/A (0.11 lb ai/A) as part of a foliar program rotating with different mode of action insecticides known to be effective on cucumber beetle.
- Spray programs should begin at flowering or at the first sign of cucumber beetles.
- Make repeat applications on a 5 to 7-day spray schedule if monitoring indicates the presence of cucumber beetles.
- See the Resistance Management section of the AVAUNT eVo insect control Section 3 Federal label for additional guidance regarding insecticide resistance management.
- Thorough coverage is essential to achieve best results. Select a spray volume appropriate for the size of plants and density of foliage being treated.

RESTRICTIONS

- Do not apply more than 24 oz/A of Avaunt® eVo insect control or 0.45 lb ai/A of indoxacarb-containing products per crop.
- Make no more than 4 applications per crop.
- Do not apply more than 72 oz/A of Avaunt® eVo insect control or 1.35 lb ai/A of indoxacarb-containing products per calendar year.
- The minimum interval between sprays is 5 days.
- For ground applications, apply using a minimum of 10 gal/A of water.
