FIRST AID

CALL A POISON CONTROL CENTER OR DOCTOR IF YOU FEEL UNWELL

IF IN EYES: Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes then continue rinsing eyes. Call a poison control center or doctor for treatment advice. If eye irritation persists: Get medical advice/attention.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by the poison control center or doctor. Have a person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment.

STORAGE: Store in a cool, dry place. Keep containers tightly closed. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Keep away from food, feed, or other products, especially oxidizing agents, to prevent contamination. **Do not allow product to freeze**.

DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent). Do not reuse container. Recycling decontaminated containers is the best option of container disposal. GENERAL INFORMATION

OPTIFY[™] A20 is a low-foaming, convenient premix of ammonium sulfate water conditioner and NPE-free surfactant designed overcome hard water issues. OPTIFY[™] A20 provides fast surfactant wetting on the leaf, contains a humectant that keeps pesticides active on the leaf longer, and provides ammonium to help increase plant uptake of pesticide through the leaf surface.

DIRECTIONS FOR USE SHAKE WELL BEFORE USING

Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages, rates and restrictions have precedence over DIRECTIONS FOR USE referred to on this label.

MIXING: Fill spray tank half full with water and start agitation. Always add OPTIFY[™] A20 first with the agitator running. Then add pesticides and continue to fill spray tank.
