### **GENERAL INFORMATION**

Valcheck COC is a non-ionic blend of highly refined paraffinic crop oil and surfactant designed to optimize the performance of certain herbicides in post emergence applications. The addition of this product to the spray tank utilizes the penetrating, non-evaporating properties of a paraffinic crop oil and the wetting and dispersing characteristics of a surfactant blend. When used as directed, Valcheck COC increases the activity of herbicides by aiding in the deposition, absorption and retention of active ingredients on leaf and stem surfaces. Therefore, care must be in treating crops during periods when plants are subjected to drought stress, high temperatures, and high humidity. **NOT FOR AQUATIC USE IN CALIFORNIA OR WASHINGTON STATE.**

**ENVIRONMENTAL HAZARDS:** Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high-water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

### **DIRECTIONS FOR USE**

Generally, use 1-4 quarts in 15-50 gallons of water. Do not exceed 2.5% volume of spray solution. For best mixing results, fill the spray tank half full, add herbicide components, and add Valcheck COC last, and provide good agitation until tank is full.
