# **Mixing Instructions:**

SHAKE WELL OR RECIRCULATE BEFORE USE

- 1. Fill sprayer 1/3 to 1/2 full of water
- 2. Add Valcheck AMS to the agitating spray tank
- 3. Add dry flowables or dispersable granules
- 4. Add emulsifiable concentrates
- 5. Continue to agitate until tank is full

## **Recommended Rates**

Each gallon of Valcheck AMS contains 3.4 pounds of ammonium sulfate. To meet various label recommendations, include:

- 2.5 gallons of Valcheck AMS per 100 gallons to equal 8.5 pounds of ammonium sulfate per 100 gallons.
- 3 quarts per acre of Valcheck AMS o equal 2.5 pounds of ammonium sulfate per acre.
- 1.2 quarts of Valcheck AMS is equal to 1 pound of ammonium sulfate.
