### PRECAUTIONARY STATEMENTS

### GENERAL INFORMATION

**Optify® HSMSO** is a high surfactant modified vegetable oil that improves droplet spreading, cuticular penetration, and spray droplet sizing of glyphosate and its tank mix partners. **Optify® HSMSO** is designed for use at a lower use rate than traditional methylated seed oil-based adjuvants with a broad range of herbicides, fungicides, and insecticides where methylated seed oil-based adjuvants are recommended. **Optify® HSMSO** can be applied by ground or air. Good judgment and sound application technology must always be followed when spraying pesticides.

### DIRECTIONS FOR USE

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.

### MIXING INSTRUCTIONS

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add **Optify® HSMSO** last to the agitating spray tank

### RECOMMENDED RATES

**Optify® HSMSO** should be applied at a rate of 1-3 quarts per 100 gallons (0.25 – 0.75% v/v) in ground, aerial, low volume or CDA applications. If conventional methylated seed oil concentrate is recommended at a rate of 1-2 pints per acre replace with **Optify® HSMSO** at a rate of 0.5-1 pint per acre. **Optify® HSMSO** rates are generally one half the rates of conventional methylated seed oil concentrates.

### STORAGE AND DISPOSAL

**Storage:** Store tightly closed containers in dry, well-ventilated area, away from excessive heat and incompatible materials. Do not store near feed or food.

**Disposal:** Do not reuse product containers. Triple rinse (or equivalent), then offer for recycling at an ACRC site (go to <http://www.agrecycling.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.
