These requirements differ from the classification criteria and hazard information required for safety data sheets (SDS), and for workplace labels of non pesticide chemicals.

The hazard information required on the pesticide label is reproduced below:

CAUTION: Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Harmful or fatal if swallowed. Avoid breathing spray mist.

Personal Protective Equipment (PPE):

Applicators using spray equipment mounted on their backs must wear:

- Coveralls over long-sleeved shirt and long pants,
- Chemical-resistant footwear plus socks, and
- Waterproof gloves.

Mixers, loaders, all other applicators, flaggers, and other handlers must wear: long-sleeved shirt and long pants, waterproof gloves, shoes plus socks, and chemical-resistant apron, when mixing/loading, cleaning up spills, cleaning equipment, or otherwise exposed to the concentrate. See engineering controls for additional requirements.

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry. Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. DO NOT reuse them.

Engineering Controls:

Mixers and loaders supporting aerial applications at a rate greater than 3 lbs.AI/A must use a closed system that meets the requirements for dermal protection listed in the Worker Protection Standard (WPS) for Agricultural Pesticides [40 CFR 170.240(d)(4)] and must:

- wear the personal protective equipment (PPE) required for mixers and loaders,
- wear protective eyewear if the system operates under pressure, and
- be provided and have immediately available for use in an emergency, such as a spill or equipment breakdown: chemical resistant footwear.

Pilots must use an enclosed cockpit in a manner that is consistent with the WPS for Agricultural Pesticides [40 CFR170.240(d)(6)]. Pilots must wear the PPE required on this labeling for applicators, however, they need not wear waterproof gloves when using an enclosed cockpit.

Flaggers supporting aerial applications must use an enclosed cab that meets the definition on the Worker Protection Standard for Agricultural Pesticides [40 CFR 170.240 (d)(5)] for dermal protection

When applicators use enclosed cabs in a manner that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240 (d) (5)], the handler PPE requirements may be reduced or modified as specified in the WPS.

Environmental Hazards:

This pesticide is toxic to aquatic invertebrates. DO NOT apply directly to water, to areas where water is present or to intertidal areas below the mean high-water mark. DO NOT apply when weather conditions favor drift from treated areas. Runoff and drift from treated areas may be hazardous to aquatic organisms in neighboring areas. DO NOT contaminate water when disposing of equipment washwaters or rinsate.

Atrazine can travel (seep or leach) through soil and can enter groundwater which may be used as drinking water. Atrazine has been found in groundwater. Users are advised not to apply atrazine to sand and loamy sand soils where the water table (groundwater) is close to the surface and where these soils are very permeable, i.e., well-drained. Your local agricultural agencies can provide further information on the type of soil in your area and the location of groundwater.

Product must not be mixed or loaded within 50 feet of intermittent streams and rivers, natural or impounded lakes and reservoirs. Product must not be applied within 66 feet of points where field surface water runoff enters perennial or intermittent streams and rivers or within 200 feet of natural or impounded lakes and reservoirs. If this product is applied to highly erodible land, the 66 foot buffer or setback from runoff entry points must be planted to crop, or seeded with grass or other suitable crop.

Product must not be mixed or loaded, or used within 50 feet of all wells including abandoned wells, drainage wells, and sink holes. Operations that involve mixing, loading, rinsing, or washing of this product into or from pesticide handling or application equipment or containers within 50 ft. of any well are prohibited, unless conducted on an impervious pad constructed to withstand the weight of the heaviest load that may be positioned on or moved across the pad. Such a pad shall be designed and maintained to contain any product spills or equipment leaks, container or equipment rinse or wash water, and rain water that may fall on the pad. Surface water shall not be allowed to either flow over or from the pad, which means the pad must be self-contained. The pad shall be sloped to facilitate material removal. An unroofed pad shall be of sufficient capacity to contain at a minimum 110% of the capacity of the largest pesticide container or application equipment on the pad. A pad that is covered by a roof of sufficient size to completely exclude precipitation from contact with the pad shall have a minimum containment of

100% of the capacity of the largest pesticide container or application equipment on the pad. Containment capacities as described above shall be maintained at all times. The above-specified minimum containment capacities do not apply to vehicles when delivering pesticide to the mixing/ loading sites.

Additional State imposed requirements regarding well-head setbacks and operational area containment must be observed.

An in-field downwind buffer of 15 feet (4.6 meters) for ground applications and 150 feet (46 meters) for aerial applications is required:
 - from the edge of all streams and rivers as well as the high-tide line for all estuarine/marine environments, and
 - from threatened and endangered species critical habitat and/or species locations.

One of the following restrictions must be used in applying atrazine to tile-outletted terraced fields containing standpipes:
 - DO NOT apply this product within 66 feet of standpipes in tile-outletted terraced fields.
 - Apply this product to the entire tile-outletted terraced field and immediately incorporate it to a depth of 2-3 inches in the entire field.
 - Apply this product to the entire tile-outletted terraced field under a no-till practice only when a high crop residue management practice is practiced. High crop residue management is described as a crop management practice where little or no crop residue is removed from the field during and after crop harvest.

Groundwater contamination may be reduced by diking and flooring of permanent liquid bulk storage sites with an impermeable material.

NON-TARGET ORGANISM ADVISORY STATEMENT
