**PRECAUTIONARY STATEMENTS:**

**Prevention:** Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Wash hands, face and other affected areas thoroughly after handling. Wear protective gloves, protective clothing, eye protection, face protection. Do not eat, drink or smoke when using this product. Avoid breathing fumes, mist, vapors or spray. Use only outdoors or in a well-ventilated area. Avoid release to the environment.

**Response:** **If in eyes:** Rinse cautiously with water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. **SECTION 4: FIRST AID MEASURES**

**Inhalation:** Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation occurs.
