SECTION 2: HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW: Dark brown liquid with organic odor. Flammable liquid. Causes severe eye irritation. May be harmful if inhaled.

SECTION 4: FIRST AID MEASURES
