Metribuzin is a chemical which can travel (seep or leach) through soil and can enter groundwater which may be used as drinking water. Metribuzin has been found in groundwa¬ter as a result of agricultural use. Users are advised not to apply metribuzin where the water table (groundwater) is close to the surface and where the soils are very permeable, i.e., well drained. Your local agricultural agencies can provide further information on the type of soil in your area and the location of groundwater.

#### Surface Water Advisory

Metolachlor has the potential to contaminate surface water through ground spray drift. Under some conditions, metolachlor may also have a high potential for runoff into surface water (primarily via dissolution in runoff water) for several months post-application. These include poorly draining or wet soils with readily visible slopes toward adjacent surface waters, frequently flooded areas, areas over-laying extremely shallow ground water, areas with in-field canals or ditches that drain to surface water, areas not separated from adjacent surface waters with vegetated filter strips, and areas over-laying tile drainage systems that drain to surface water.

#### Mixing/Loading Instructions

Care must be taken when using this product to prevent back-siphoning into wells, spills, or improper disposal of excess pesticide, spray mixtures, or rinsates. Check-valves or anti-siphoning devices must be used on all mixing and/or irrigation equipment.

This product must not be mixed or loaded, or used within 50 ft. of all wells, including abandoned wells, drainage wells, and sink holes.
