### SECTION 4: FIRST AID MEASURES

<b>Inhalation:</b>	Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation occurs.
<b>Ingestion:</b>	Seek medical attention or call a poison control center for treatment advice. Do not induce vomiting unless instructed to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
